#### New Veterans' Education Bill Signed into Law

On August 16, President Trump signed into law the largest expansion of educational benefits to GI Bill in nearly ten years. The Harry W. Colmery Veterans Educational Assistance Act (Act) eliminates the provision of the GI Bill that gave veterans a 15-year window from their last active duty discharge date to use their educational assistance benefits. The Act also gives full GI Bill benefits to Purple Heart recipients and eliminates a loophole for reservists who were deployed for disasters.

The Act passed both chambers of Congress unanimously.

## Two Legislative Bills Would Affect Florida School Boards

Senator Dennis Baxley has proposed SB 192, which would establish hat two or more members of a school board or other elected body may meet privately, without public notice, if no official acts or public business are to occur.

Senator Gereg Steub has proposed SJR 194, which would set term limits on elected school board members.

Neither bill currently has a House companion version.

## Ruling: Connecticut Supreme Court Holds Schools Have "Duty to Warn" of Tick Bites

The Connecticut Supreme Court ruled that schools have a "duty to warn parents and students of potential hazards," such as dangerous insect bites, associated with field trips. The Court allowed a \$41.7 million verdict awarded to a student who became disabled after a school trip to China, where he was bitten by a tick that inflicted encephalitis.

### University of Miami Announces it Won't Make Agreement with Cuban Universities

The University of Miami announced that it will not establish any agreements with any Cuban universities or the Cuban Government. The announcement came after a meeting between the University of Miami and members if the Cuban exile community. Members of the Cuban exile community have voiced opposition to any agreements between the University and the Cuban government.

## A New Study Provides Insight into Legacy Admissions Process

On the heels of the U.S. Justice Department's ongoing investigation into allegations of illegal discrimination programs in certain elite colleges related to advantages given to children of alumni, a recent study supports the suggestion that legacy applicants receive preferential treatment in the admissions process.

The Naviance database assessed 15,402 legacy applications from high school classes of 2014-17 and 64 colleges with 100 or more legacy applications. The study shows much higher admit rates for legacy applicants. Indeed, the average acceptance rate across the analyzed institutions was 31% higher for legacy applications. The data may not demonstrate bias, but certainly suggests correlation.

#### **ABA Launches Legal Education Commission**

The American Bar Association instituted a 10-member task force to address the challenging job market for new lawyers. Dean of University of Miami School of Law, Patricia White, will chair the task force. The task force will focus on issues in legal education, which has recently been a priority of the Department of Education. The Department has placed pressure on higher education accreditors, like the ABA, to seek accountability from its member institutions.
